

Dennis Murray called the meeting to order at 5 p.m., after the Invocation, given by Dick Brady, and the Pledge of Allegiance.

The Clerk called the roll and the following Commissioners responded: Greg Lockhart, Nikki Lloyd, Dennis Murray, Naomi Twine, Dave Waddington and Dick Brady.

Upon motion of Greg Lockhart and second of Dave Waddington, the commission voted to excuse Wes Poole. The President declared the motion passed.

Upon motion of Dave Waddington and second of Nikki Lloyd, the Commission voted to approve the minutes of the February 27 meeting and suspend the formal reading. The President declared the motion passed.

Jacquelyn Betzel-Conrad said she teaches third grade at Ontario School where there is a **butterfly pollinator**. The Monarchs are in trouble as well as other insects and Monarchs have been impacted by changes taking place and she wants to try to help them. This is a partnership between Bowling Green State University, iEvolvewithStem, Ohio State University and Perkins and Sandusky City Schools where butterflies are tagged and released. In the fall, the students collect the seeds from the pollinator gardens to be sorted, cleaned and bagged to chill and germinate. Monarch butterflies are in danger as are bumblebees which head to Mexico each year and there are three or four generations moving back north each year. The milkweed plant is the host plant

for the Monarch caterpillar but are facing starvation because this plant is being killed off by pesticides and other things. The population in the 1990's was much higher and there is an eleven to fifty percent chance of Monarch reduction over the next twenty years and has dropped in the last year by twenty-seven percent. During World War II, Japan had control of the Pacific Islands and materials from a specific Milkweed pod were used to stuff vests for the Navy. In Canada, there is a company now commercially harvesting Milkweed and using the fibers to make jackets. San Antonio is a Monarch community and have pledged to help with pollinator gardens, promote planting of milkweed and native nectar plants, educate the public about the plight of monarchs and promote citizen science research and engagement. Dennis Murray said one of the most important things shared is 80% of our food ultimately comes from plants which are pollinated and with the decimation of the butterfly population, bee and other insects, this becomes a food security and safety issue.

Upon motion of Dave Waddington and second of Greg Lockhart, the commission voted to take a pledge to make Sandusky a Monarch Butterfly City through the use of establishing more pollinator gardens throughout the city. The President declared the motion passed.

AUDIENCE PARTICIPATION

Duff Milkie, representing Cedar Fair, said he is here regarding Item #4 which concerns a study for "The Landing", which is property on Cleveland Road formerly known as Griffing Airport. Cedar Fair sees this as a community builder through cooperation with Erie MetroParks and the City of Sandusky. As part of this, they wanted to activate the land against Sandusky Bay which has a lot of environmentally-sensitive areas and will make for a nice park. They wanted to ensure it would be an active space as well as a place to interact with nature and that it would be a connective piece to the other assets the city and the park already have to emphasize the natural resources and park system. This would be a good project to bring a focal point and Cedar Fair is happy to be part of donating this land to make it come about. The city has stepped up and taken the lead by getting a professional planning organization involved and this helps coordinate everything in the area to provide the best possible product and thanked the city's leadership as well as Erie MetroParks which will deliver a great asset for the city. Dennis Murray thanked Cedar Fair for the generous benefit they are helping to provide for Sandusky and the greater area.

Clarence Rhoney, active member of the Board of Directors with Sandusky Amvets Baseball League, said he is asking to help with upgrading the ballparks by obtaining dirt and fencing. Kids, parents and little children are running through while games are being played and this is a safety issue. The old fencing from the Junior league fields could be used but the Amvets does not know the status of any of the new fencing or dirt. They are trying to make things better for the younger generation and the only way to do this is for everyone to participate as a whole. The concession stand also need work with the roofing. It is not fair for Lions Park to receive a lot of upgrades but the ballparks are not done. Dennis Murray said there are a lot of investments planned for Amvets Park and to speak with Brad Link about the particulars. Dennis Murray thanked Mr. Rhoney for working with the youth and for his advocacy.

Jeff Sherman, 1212 Butler Street, said he understands the city will keep the Youth Commission active in moving forward and appreciates this. Monica Hall-Pierson and Jeff did a lot of groundwork and met last week to put together a plan to present to the city about this and they are serious about having something for our youth. Dreams have been taken away from our youth and it is up to all of us to get this back for them. Things are planned with the city's help and support and the more hands on deck, the more successful the program will be.

Herman Robinson, 1601 Oakmont Lane, said the doors at City Hall were locked during the last commission meeting and this provided a setback. In the spirit of continuous improvement, it is possible the commission might be missing an opportunity to validate inclusiveness and transparency touted at recent meetings as the doors to the building were locked. Meeting lockouts may or may not be malicious but it constitutes the perception of denied access. Herman Robinson said he did gain access to the building through the Police Department but was 25 – 30

minutes late. Locked doors do not allow nor do they foster inclusion or transparency. Dennis Murray said he did not learn about this until after the February 27 meeting but noted the commissioners do offer coffee meetings, commission meetings and other public meetings and apologized for the snafu.

Tim Schwanger, 362 Sheffield Way, asked how many acres are involved with The Landing project and how many of them are owned by the city, Cedar Point, Huron and Huron Township (Item #4).

PUBLIC HEARING

Dennis Murray announced the opening of a Public Hearing regarding the 2017 Budget for the City of Sandusky.

Hank Solowiej said a budget is to prioritize the use of limited resources; we have an infinite demand with a finite set of resources. In 2016, the commission unanimously adopted a Strategic Plan which serves as a blueprint and a guide for the budgeting decisions we make going forward. The five main focus points of the plan included: vibrant city, livable city, connected city, destination city and a celebrated city. Our budget includes prioritization in each of these five areas. A balanced general fund budget is being presented tonight and it is anticipated will add to the reserve by year-end. The reserve is estimated to be at about 20% which is in our target range. General fund revenues are estimated to be approximately \$23 million which is an increase of about four percent from 2016. Our general fund expenses are estimated to be about \$22.9 million. The Issue 8 investment is \$2.3 million for housing, economic development and infrastructure (+\$600,000 from 2016). We are looking to add approximately seven employees to the general fund budget including: Maintenance positions at Oakland Cemetery & Horticultural Services (2), GIS position in IT, Project Engineer in Public Works, Utility/Street Superintendent in Public Works, Animal Control Officer in Police Department and funding for an Assistant Chief in the SFD. (Some are for one full year while others are based upon when they may or may not be hired.) We feel we are presenting a balanced budget which meets the goals and objectives of the Strategic Plan; the Audit/Finance Committee also recommended this budget at its February meeting. Eric Wobser said we are excited about the revenue being strong and our ability to invest more in infrastructure which is a critical issue. The vast majority of the new positions are directly related to providing and enhancing services. In addition to the full-time employees mentioned, quite a few seasonal employees will come on in the service divisions to enhance what we do in the community. We are trying to direct this money where people will see it out on the street either by repaving roads, redoing parks or providing better services to our citizens. Dick Brady said he is thrilled we will be able to increase the dollars we are spending for infrastructure by fifty percent. There is not a week that goes by where he does not get a call from a resident about repairing their streets and/or potholes. We can never get to all of them fast enough, but if we can continue to push \$1 to \$1.5 million into infrastructure year after year, this will make a huge difference in the future for its cumulative effect. Dennis Murray said some of these new positions may not come to fruition if projections do not get to the level we think they should be later in the year should the economy turn. This proposed budget has been out for three or four weeks now in its current form and people have had the opportunity to digest it and ask questions about it.

The President declared the Public Hearing closed.

Eric Wobser asked to interrupt the regular meeting to introduce a guest visitor in our midst - **Jay Crawford with ESPN**. Jay is a 1983 graduate of Perkins High School and is in town today helping with a video for the State of the State to welcome the Governor. Jay is a huge supporter of Sandusky and the surrounding area and he said he had a wonderful day selling Sandusky and carries a piece of Sandusky with him wherever he goes; he loves the work being done by the city. There are some exciting projects going on here and urged the city to keep forging forward. The area has a ton to offer and is a little secret in Ohio a lot of people do not know about.

Discussion: Greg Lockhart said as the liaison to the ADA Advisory Board, the members expressed their dissatisfaction at the last meeting with the proposed changes as they were not apprised of them. They are not happy about merging with the Fair Housing Board as they do not know anything about it. There is a problem with making these kinds of changes without the consent of the people involved and they do not know what their place is on the Board. The number and frequency of meetings is of contention as the members would like to meet monthly in order to be taken seriously. The number of members is a problem as some people represent the elderly and disabled while others represent fair housing and the two do not necessarily meet in the middle. It is important to have volunteers but it is really important to have the feedback of disabled persons on the ADA and the number of members should be determined by the current representation. If there are three, four or five disabled individuals who would like to join, we would like to have them and this might make the numbers somewhat lopsided. At this point, Greg Lockhart said he would like to hold off until clarification is made with members of the Fair Housing Board. Justin Harris said at one time, the initial proposed amendment was mandating two meetings each year but has since spoken with Greg Lockhart and this was changed to a minimum of four mandatory meetings each year. The Board still has the ability to meet on an “as needed basis” if the Chairperson would call for a special meeting. They would not be precluded from meeting on a monthly basis, if necessary.

Commission) of the Codified Ordinances of the City of Sandusky, in the manner and way specifically set forth hereinbelow; and declaring that this ordinance shall take effect under suspension of the rules as contained in and in accordance with Section 13 of the City Charter.

Upon motion of Naomi Twine and second of Nikki Lloyd, the Commission voted to approve this ordinance at second reading.

Upon motion of Naomi Twine and second of Nikki Lloyd, the commission voted to amend the legislation to include one non-profit, one clergy and five citizen members to the new CRC. Roll call on the motion: Yeas: Nikki Lloyd, Dennis Murray, Naomi Twine, Dave Waddington and Dick Brady, 5. Nays: Greg Lockhart, 1. The President declared the amendment to the legislation passed.

Upon motion of Naomi Twine and second of Nikki Lloyd, the commission voted to adjust the membership to include one (1) non-profit member, one (1) clergy member and five additional citizens from the community.

Discussion: Naomi Twine said she is making this motion after assessing public feedback received since the last commission meeting and after following up with the N.A.A.C.P. Greg Lockhart said it seems there should be separation of a religious member as this may not meet the test to separate city and religion and we could potentially be pursued by the A.C.L.U. The Human Relations Commission does not necessarily need to be repealed although there perhaps could be some changes but does not think this is necessary. This committee is built on mitigating tension with the city and its purpose is for the city to have a better relationship. We have seen changes made without consent of the citizens or without being properly vetted and this has already created tensions. The HRC has been around for a long time and things have gone on in the city but we have not had a public meeting about something of great public interest and he cannot support anything like this ever. Justin Harris said the previous legislation for HRC defined a mission and left the purpose, duties, obligations and responsibilities to be created through By-Laws which were not codified. In researching, similar Community Relations Commissions were looked at throughout the country and it was determined the duties and responsibilities should be codified to vest their powers and rights in our code book. The proposed Section 152 enumerates Items A – L which include promoting and developing a mutual understanding and respect of all racial, religious, nationality, cultural and ethnic groups in the city; aid in seeing no person is deprived of equal service by city government because of discriminatory practice; initiate and conduct mediation hearings at the request of the City Commission or City Manager; confer with the Law Director on complaints pertaining to Sandusky or criminal conduct as it appears to require a legal process; verify information related to complaints of alleged discriminatory practices; investigate, upon request of the City Commission or City Manager allegations of discriminatory incidents and make recommendations for corrective actions; formulate and disseminate programs with community information, educational materials or reports which will assist in the elimination of prejudice, tolerance and discrimination which promote goodwill and will result in better human relations; provide recommendations upon request of the city Human Resources Department and/or City Manager to help improve employment opportunities and city government for persons who have traditionally been targets of discrimination in employment; assist community groups and various fraternal service and benevolent organizations upon request in the promotion of educational campaigns devoted to the elimination or prejudices, racial or neighborhood tensions, intolerance and discrimination; conduct research to ascertain the status and treatment of racial, religious and ethnic groups in the city and the best means of aggressively improving human relations in Sandusky; cooperate with and render assistance with the city and other branches of city government in the area of human rights; prepare and publish annual reports as is deemed necessary concerning problems relating to discrimination, racial tensions and other human relations concerns. The previous HRC legislation allowed for a Director which was the only city board or commission which had a paid director. The new statute provides for the city's Neighborhood Outreach Coordinator to serve as a staff member or liaison to the committee and spells out what powers are permitted as a matter of law. There have been

conversations about this perhaps weakening the role of the members, but this simply enumerates and spells out their obligations and duties to the city. Dick Brady said if he reads this correctly, it is similar to the ADA legislation just passed in that the new board is required to meet four times each year, but this is not a constraining number; they can meet once each month if they would like to. Greg Lockhart said the concerns he raises are concerns of the citizens and of former members of the HRC who were not consulted when these changes were made. In addition to the HRC and the ADA members, he has heard people say this legislation spells out what the HRC cannot do but no other committees have the duties which they cannot perform spelled out. Greg Lockhart asked to define the complaint process and Justin Harris said the process will not change and complaints can be provided to a City Commissioner, Chairperson of the CRC, the Law Director or any other Department Head of the city to get filtered to the members. We would like to provide more education in the future as to the existence of the Community Relations Commission. Naomi Twine said this has been publicly discussed and people have had opportunities to express their opinions which they did at the last commission meeting as well at the last HRC meeting. When she reached out to Greg Lockhart, Naomi Twine said he did not express any concerns to be addressed and this has gone through the process. There will still be an opportunity for people to have their issues addressed and there will be a diverse committee of people to hear complaints, questions, issues and concerns and take a methodical approach to resolving them. Nothing is being taken away; we are trying to make this better.

PROFESSIONAL DESIGN SERVICES AGREEMENT WITH ENVIRONMENTAL DESIGN GROUP FOR THE LANDING PROJECT

Budgetary Information: The total cost of this conceptual design project is \$160,000 to be split accordingly: City of Sandusky in the amount of \$60,000, Cedar Fair in the amount of \$50,000, and Erie County MetroParks in the amount of \$50,000.

ORDINANCE NO. 17-058: It is requested an ordinance be passed authorizing and directing the City Manager to enter into an agreement for professional design services with Environmental Design Group, LLC, of Akron, Ohio, for The Landing Project; and declaring that this Ordinance shall take immediate effect in accordance with Section 14 of the City Charter.

Upon motion of Dave Waddington and second of Nikki Lloyd, the Commission voted to approve this ordinance under suspension of the rules and in accordance with Section 14 of the City Charter.

Discussion: Eric Wobser said the vast majority, if not all of the waterfront property, does sit within the City of Sandusky although there is a primary area proposed for public improvements, and secondary area which is both East and West of the former Griffing property. City property could potentially connect to Erie MetroParks, Perkins Township and Huron Township. It was important when working on the first phase of the Sports Force project to note Cedar Fair wanted to see the northern waterfront portion of the property become publicly accessible and give people an opportunity to get out on the water which they could before. Cedar Fair purchased this to create a premiere public access point to Sandusky Bay which is called for in the city's Bicentennial Vision as well as seeing increased recreational tourism such as kayaking, bicycling, and bird watching. We saw the opportunity and began a conversation with Cedar Fair and Erie MetroParks to look at making improvements to the 27 acres known as "The Landing" and linked into a linear Sandusky Bay Pathway for as much of the city as possible. The Erie MetroParks have acquired a lot of property through conservation efforts over the last few decades but the most significant portion of this is land owned by Cedar Fair. Aaron Klein said the breakdown of this \$160,000 project includes \$60,000 from the City of Sandusky, \$50,000 from Cedar Fair and \$50,000 from Erie MetroParks. This breakdown does not necessarily represent the land ownership. The RFQ process ultimately recommends one firm although initially the cost higher than anticipated. Some items had to be eliminated including a larger public involvement process although there will be some sessions to get them involved. The city's additional \$10,000 commitment will help to keep the public involved and engaged throughout the process while still honoring the commitments from Cedar Fair and Erie MetroParks. Dave Waddington said he was at this property this weekend and said this provides a great view. Birdwatching is very big and this area can be like Maumee Bay after the pathway is built for biking and walking. Dennis Murray said this is an incredible opportunity to provide another public access to our waterfront in an area which was previously underutilized. This will generate far more real estate tax dollars, income tax dollars and public access where there was none before.

Discussion: Aaron Klein said the pavement condition analysis noted Gartland Avenue was one of the worst streets in the city. There were a lot of basement backups and flooding in this area and the sanitary sewers are low while the storm sewers are immediately above although they are connected to the same manhole (over/under sewers). When it rains, the sanitary sewer surcharges to the storm sewer which causes a little relief, but not enough. The trees are huge and we get a lot of complaints about the sidewalks because of this, but did not want to include this street in the sidewalk program last year if we had to take care of the sewers too. We are looking at replacing sidewalks, putting in a new storm sewer and creating new connections for property owners to tie into. The project cost includes much more than a simple resurfacing. Dennis Murray said we want to get to every street which we can, but do not want to “band aid” properties and appreciate this approach to doing things the right way rather than the quick way.

RESOLUTION NO. 018-17R: It is requested a resolution be passed declaring the necessity for the City to proceed with the proposed Lincoln Street Water and Sewer Replacement Project; approving the specifications and engineer’s estimate of cost thereof; and directing the City Manager to advertise for and receive bids in relation thereto; and declaring that this Resolution shall take immediate effect in accordance with Section 14 of the City Charter.

Discussion: Dick Brady said this is a little-known street situated behind the Better Half Diner with only four homes. Although it may seem like a lot of money to repair a street and water line, this line has cost the city a lot in repair and replacement over the years breaking on more than an annual basis. This line serves not only residents of Lincoln Street, but a large portion of this end of town. These kinds of things are always expensive but with our Public Works staff, they are always justified and he has not been able to find any waste in this department while serving as the liaison. There is a lot on their plate, more than 40 projects in excess of \$50 million over the next four of five years and the staff is up to their game.

There is concern that if pipes shift and burst at the coupling, smaller parallel pipes would have to be used. Mosser, who is currently onsite for the PAC project, supplied a cost on Tuesday of \$11,636.10. Per Section 24 of the City Charter, which allows for this emergency repair to be performed, staff has given Mosser a notice to proceed because the materials take at least one week to arrive. Staff is asking for a motion to proceed with the work but will ask for formal commission approval on March 27.

Kelly Kresser said as a merged board, the ADA/Fair Housing Board would require seven members; currently Kathy Wickens, Martha Thompson, Diane Corso and Carol Steele are members of the ADA Board and Chris Tulupan, Lovey Leavell, John Jacobs and Barry Vermeeren are on the Fair Housing Board. There are eight persons who are currently on one or the other and there are seven vacancies. We also received volunteer applications from Ruth Haley, Pamela Riggs, Patricia Ellington, Patricia Stewart, William Schram, Jackie Collins, Mike Metzger, Camille Sibbitt, Brian Stanley and Kathleen Linz. With concerns about the merger, it is suggested to hold off until the next commission meeting to make contact with these persons and garner their interest. Greg Lockhart said this is the problem indicated earlier as members currently on the ADA Advisory Board would like to remain, but the Fair Housing Board has not met and we have not yet reached out to them. Kathy Linz is related to Dr. Linz who started the Board and it would be a shame to not have her as a

member of the committee. If we had listened to the people who have been on the ADA Advisory Board for years, we would not be in this position. Greg Lockhart suggested revisiting listening to people who are involved on these boards and wait to make a decision on this. Dennis Murray said he would appreciate Greg Lockhart's recommendation as the liaison and engaging those who wish to serve and those who do not. Dennis Murray said the Fair Housing Board has met only infrequently and some of those persons may not even remember they are on it. We will work to determine who is interested in serving on this merged board.

NEW BUSINESS

Dave Waddington said he read Senator Randy Gardner is concerned about the **E.P.A. and its shrinking budget as far as water and our Great Lakes**. Dave Waddington said he is concerned about what is going to happen with Sandusky Bay and allowing dumping during the next few years. If this does happen, we could go back twenty years as far as what we are trying to do to clean up Lake Erie with the algal blooms, farm runoff and other things. We should send a letter of support to Senator Gardner and Governor Kasich about this. Dennis Murray said over \$10 billion of commerce is based upon the Lake, tourism in the State of Ohio and over one million businesses are supported by the water resources and this is a huge deal to Ohio's economy as well as to our local economy. Dennis Murray also suggested adding sending this letter to our federal representatives: Congresswoman Marcy Kaptur, Congressman Jim Jordan and Senators Brown and Portman. Aaron Klein said the city is doing the best it can regardless of the outcome of the President's Bill. A couple of weeks ago there was a one million dollar initiative to design three to four projects for eco-system restoration for our Coastal Wetlands to make sure we are doing our part with Sandusky Bay through a grant from the Great Lakes Restoration Initiative (GLRI) and this is part of the funding proposed to be cut. In all of the conversations Aaron Klein has had, important people are lobbying for efforts for this funding. We have also had discussions with the ODNR which is interested in taking another approach to Sandusky Bay as well. The city will also be considering future legislation for an ODNR initiative to develop a Comprehensive Master Plan for all of Sandusky Bay with GLRI funding. We are being proactive and involved and are speaking with the necessary persons to ensure everything that can be done is being done to keep this funding as high as possible. Dave Waddington said a reduction in funding may cause the city to have extra costs to treat our water and waste water. Dennis Murray asked Justin Harris and Aaron Klein to get together and draft a letter to advise our legislators of the city's concerns about this funding.

Upon motion of Dick Brady and second of Naomi Twine, the commission voted to hold an executive session regarding Personnel, City Manager. Roll call on the motion: Yeas: Greg Lockhart, Nikki Lloyd, Dennis Murray, Naomi Twine, Dave Waddington and Dick Brady, 6. The President declared the motion passed.

Upon motion of Dave Waddington and second of Naomi Twine, the commission voted to hold a Public Hearing at the April 24, 2017 commission meeting regarding zoning amendments for transient rentals in Sandusky. Roll call on the motion: Yeas: Greg Lockhart, Nikki Lloyd, Dennis Murray, Naomi Twine, Dave Waddington and Dick Brady, 6. The President declared the motion passed.

AUDIENCE PARTICIPATION

Sharon Johnson, 1139 Fifth Street, said the committee information was rolled out improperly and without the committee members knowing about it. Sharon Johnson is on the Revolving Loan Fund (RLF) Committee which is being discontinued for the third time and the Economic Development Committee is being reorganized and asked what will happen to the \$600,000 in the RLF. Justin Harris said the money available does not go with the committee(s); the new Economic Incentive Committee will disburse the grants and loan funds to remain active and be administered through the Finance Office. Sharon Johnson said one company got money from the Revolving Loan fund and then a grant from the Economic Development Committee and triple-dipped and the city needs to restrict this from happening.

Monica Hall, 813 Perry Street, said she has concerns about the street conditions and hopes they will be taken care of this weekend with the storm coming.

Vicki Bird, Wilbert Street, said perhaps the city should also send a letter about the Great Lakes and the defunding of the EPA to President Donald Trump. Sandusky Bay is attached to Lake Erie and we live on one of seven fresh water sources in the country and does not know why it is being considered to take this funding away. We are the ones getting sick, losing our fish and whose water is turning green and this affects our economy. Vicki Bird thanked the city for cleaning up

the former G & C Foundry property. Vicki Bird said she did not know the city had a Human Relations Commission and this is important, but is curious about what type of non-profit or clergy and Naomi Twine said any would be welcome. The city needs to be very careful so the ACLU does not knock on our doors. If someone has a complaint, Vicki Bird asked where this would go and Dennis Murray said these can come through various different channels. Dennis Murray said there has not been a problem with things finding their way to the HRC that he knows of.

Herman Robinson, 1601 Oakmont Lane, said he believes there is good reason for having a non-profit and clergy representative on the HRC because of their due diligence in terms of benevolence and being trained, directed and duty-bound to do right. This goes to the dynamic and structure of the process ensuring we have a certain level of focus with the committee. There are two ministry groups in Sandusky including the Inter-Denominational Ministerial Alliance and the Sandusky Area Ministerial Alliance including Catholics, blacks, whites, women and men; these are resources to get the kind of participation eluded to. Chief Orzech should have an opportunity to speak to police protocols about the use of Tasers to educate the youth about consequences for their behavior, or lack thereof. We need summer jobs for our youth and for the last three years, Herman Robison has spoken with people at the city, the county and Job & Family Services (JFS) to help those with nothing to do. They need to learn how to work and in the past, Acorn Ministries has partnered with JFS to hire kids. They are mentored and coached on how to be a good citizens in terms of working. It is incredulous this Federal administration wants to take the budget from \$300 million to \$10 million for a natural resource. The loss of KBI has also impacted our area and the people who live and pay taxes in Sandusky; this was a loss of 400 tax-paying jobs or \$72 million per year.

Tim Schwanger, 362 Sheffield Way, asked what the process will be for the Jackson Street Pier and Shoreline Drive project. Dennis Murray said in an attachment to the legislation passed, there was a series of tasks to be undertaken and the March 30 meeting will simply be a kickoff meeting. Eric Wobser said this will be the start of the public process.

At 7:16 p.m., the President announced a recess of the regular session. At 7:20 p.m., the commission went into executive session.

At 7:45 p.m., the commission returned to open session.

Upon motion of Naomi Twine and second of Greg Lockhart, the commission voted to approve the written evaluation of City Manager Eric Wobser. Roll call on the motion: Yeas: Greg Lockhart, Nikki Lloyd, Dennis Murray, Naomi Twine, Dave Waddington and Dick Brady, 6. The President declared the motion passed.

Upon motion of Dave Waddington and second of Nikki Lloyd, the commission voted to increase City Manager Eric Wobser's salary by \$7,500, effective immediately.
