APPLICANT SHALL SUBMIT SCALED "AS-BUILT" DRAWINGS WITHIN 30 DAYS UPON THE COMPLETION OF THE PROPOSED WORK TO THE CITY OF SANDUSKY DEPARTMENT OF PUBLIC WORKS DIRECTOR.

EXHIBIT H.

RIGHT-OF-WAY CONSTRUCTION PERMIT

This right-of-way construction permit for the use of the public rights-of-way is granted this _____ day of _____, 20__, to _____ - (the "Grantee"), by the City of Sandusky, an Ohio Municipal Corporation (the "City").

The Grantee, its successors and assigns, is hereby granted the non-exclusive right, privilege, and authority, in accordance with the provisions of Chapter 919 of the Codified Ordinances of the City of Sandusky, to construct, install, place, repair in and under, above, across and along the streets, alleys, thoroughfares, public rights-of-way and public property at the location and for the purpose delineated in the Grantee's application.

This permit is granted by the Director of Public Works and includes all of the provisions contained in Chapter 919 of the Codified Ordinances of the City of Sandusky which set out fully the duties and obligations of the Grantee.

The Grantee by its acceptance of this permit hereby consents and agrees to comply with the provisions of Chapter 919 of the Codified Ordinances of the City of Sandusky and to any additional conditions imposed by the City as authorized by Chapter 919.
