**2019 PARTICIPANT INFORMATION**

**GUIDELINES FOR YARD WASTE SERVICE**

For your information, the following guidelines are a reminder for yard waste collection and disposal services:

1. Collection will be on Friday of each week. If a holiday falls during the week, the pickup day will be on Saturday.
2. Yard waste materials may be placed in 20-35 gallon biodegradable yard waste bags or in 20-35 gallon containers clearly marked "yard waste". Containers shall be constructed of plastic, metal or fiberglass and shall have handles of adequate strength for lifting.
3. Shrubs, brush and tree trimmings must be tied together with twine or string in package form not exceeding four (4) feet in length, four (4) inches in diameter, or sixty (60) pounds in weight.
4. Yard waste must be placed at the curb in front of the residence that has been authorized for yard waste collection and disposal services no later than 6 a.m. on the scheduled day of collection.

***PARTICIPATION***

Residents within the corporate limits of the City of Sandusky may elect to “opt in” to this program. Participation enrollment or discontinuation will be offered in January of each year for the next contract period. Interim discontinuation will be processed if a final water/sewer bill is requested or if the participating resident no longer lives at the service address. **PLEASE SEE PARTICIPATION FORM BELOW.**

***PROGRAM COST***

The cost for this service is \$11.30 per month for the contract period (\$101.70 total). The charges for this program will be shown as a separate line item on the participant’s water/sewer bill. Participant has the option to pay \$11.30 monthly or the \$101.70 as an annual (one time) charge for the contract period.

**CONTAINERS**

20-35 gallon biodegradable waste bags and/or 20-35 gallon containers (garbage cans) clearly marked "yard waste". Purchase of bags or containers is the responsibility of the participant.

**YARD WASTE QUANTITIES**

There is NO limit to the amount of yard waste collected weekly from a residence. Yard waste includes grass clippings, leaves, weeds, shrubs, brush and tree trimmings. Containers must have handles of adequate strength for lifting. Shrubs, brush and tree trimmings must be tied together with twine or string AND may not exceed 4 feet in length, 4 inches in diameter or 60 pounds in weight per bundle.
