CITY SEEKING VOLUNTEERS FOR BOARD VACANCIES

Sandusky – The City of Sandusky is accepting volunteer applications for persons to serve on the Landmark Commission and the Fire Prevention Code Board of Appeals.

The Landmark Commission was formed to review major alterations and/or demolitions to local landmark buildings, buildings and properties listed on the National Registry or within a National Registered district. At least two members of the Landmark Commission are required to have backgrounds in architecture, history, planning, archaeology or related disciplines. Annual training will be provided by the city for all members and meetings will be scheduled as needed, and minimally, four times each year.

The Fire Prevention Code Board of Appeals was established to hear and make recommendations for appeals made under the city's Fire Prevention Code. The members appointed should have some experience or training specific to fire prevention and this board meets as needed.
