## **Season Pass Holder Eligibility Regulations**

**By signing below, I agree to follow the regulations that have been established at Mills Creek Golf Course. I understand that in the instance that any of the below are not followed, I will lose the use of my season pass without refund.**

**I will sign in on the "Season Pass Holder" sheet prior to playing on the course each time that I visit the course. By signing in, I am helping the course staff to know how many golfers are on the course at all time which ensures my safety. I am also assisting the course staff in keeping an accurate round played count for the course.**

**If I will need to utilize a riding cart while on the course, I agree to purchase the privilege to utilize the cart. I will not ride a cart with another golfer unless I have purchased the privilege to use the cart. If I will be utilizing the cart for more than 9 holes, I agree to purchase the cart for 18, 27 or 36 holes. Carts should be rented immediately prior to teeing off.**

**I agree to wear the proper attire (shirt, shorts/pant, shoes) while playing on the golf course. I also understand that metal spikes are not permitted on the golf course.**

**I understand that no firearms are permitted on the golf course including the parking lot, storage barns, clubhouse, practice areas and the greens.**

**I agree to report any incident to the golf course staff that I feel may be detrimental to the safety of a player or may interfere with providing a great experience to all customers the visit the course.**

**I understand that my season pass is not valid during unspecified events and that Mills Creek Golf Course reserves the right to schedule events at the golf course which may restrict use of my season pass. Advanced notice will be posted at the clubhouse for any of the scheduled events.**

**I understand that my pass is valid anytime during the course operating hours for the season in which I have purchased it (March 15 to November 15). By purchasing this 2012 Season Pass, I understand that I may utilize my pass for the remainder of the 2011 season (September, October, November).**
